Chemical concentrates are recognized in EBOM credit IEQ 3.1. Cleaning chemicals are also addressed specifically in EBOM credit IEQ 3.3. In new construction and renovation projects, this system would qualify for an innovation point.
Contract Services Restroom Supplies	EBOM: IEQ c 3.3: Green Cleaning – Purchase of Sustainable Cleaning Products and Materials	Paper and tissues supplied contain 100% recycled content, and are Green Seal Certified, qualifying for 2x their purchasing value in LEED calculations.
Contract Services Microfiber Cleaning System	EBOM: IEQ c 3.1: Green Cleaning – High Performance Cleaning Program	Microfiber tools and wipes are recognized as sustainable cleaning products for use in High performance cleaning programs.
Contract Services Parts Cleaning	EBOM: Innovation	Auto Parts cleaning would be considered “process”, not “janitorial” cleaning. As such, the SafeWasher could qualify for an innovation point for an automotive facility seeking certification.
Contract Services Mat Services	ALL LEED SYSTEMS: Indoor Chemical and Pollutant Source Control	Walk-off mats – 10’ in travel of direction with weekly or bi-weekly cleaning/replacement, with a minimum of 2 year service contract.
Contract Services Mop Services	EBOM: IEQ c 3.1: Green Cleaning – High Performance Cleaning Program	Indoor air quality and reduction of contamination benefits are recognized as part of High performance cleaning programs in LEED.
Contract Services Towel Services	EBOM: IEQ c 3.1: Green Cleaning – High Performance Cleaning Program	Indoor air quality and reduction of contamination benefits are recognized as part of High performance cleaning programs in LEED.
