First Aid Built for the Workplace

Statistics

- There were 2.7 million nonfatal workplace injuries and illnesses reported by private industry employers in 2020.¹
- The total cost of work injuries in 2019 was \$171.0 billion.²
- Every 7 seconds, a worker is injured on the job.³
- In 2019, 37.3 million Americans, or 10.5% of the population, had diabetes.⁴
- It has been estimated that employers pay almost \$1 billion per week for direct workers' compensation costs alone.⁵

OSHA 29 CFR 1910.151(B)

"In the absence of an infirmary, clinic, or hospital in near proximity to the workplace which is used for the treatment of all injured employees, a person or persons shall be adequately trained to render first aid. Adequate first aid supplies shall be readily available."

ANSI/ISEA Z308.1-2021

"This standard establishes minimum performance requirements for first aid kits and their supplies that are intended for use in various work environments. Classification of first aid kits, designating the assortment of items and quantity of each item, is based the complexity of the work environment and level of hazards."

"First aid kits should be inspected at least monthly or following a first aid incident when product is used. Frequent inspection is recommended to ensure the completeness and usable condition of supplies to maintain compliance with this standard. Any supply beyond its marked expiration date should be replaced. Cabinet surfaces should be disinfected regularly, during restocking or following any first aid incident when product is used. Dependent on workplace environment, cabinet surfaces may need to be cleaned and disinfected more frequently. It is recommended that product is easily identified and well organized."

"When assessing risk, proximity of first aid supplies in relation to each worker is imperative. It is inadequate to base first aid kits and cabinets solely on the number of people in a work environment (i.e. 10-Person, 25-Person, 50-Person or 100-Person First Aid Kits)."

ANSI 107-2020 is the current industry consensus standard for High Visibility Safety Apparel (HVSA). The standard designates garment Types for HVSA based on the expected work environment of the wearer. The standard specifies Performance Classes within each type in terms of the minimum area of high visibility materials to be incorporated in the garment.

TYPE O (Off-road)	
	Meant for off-road applications. Provides added daytime and nighttime visual enhancement for workers in occupational environments which pose struck-by hazards from moving vehicles, equipment and machinery, but which will not include exposure to traffic on public access roadway rights-of-way or roadway temporary traffic control (TTC) zones.
TYPE R (Roadway)	
	Provides enhanced daytime and nighttime visual conspicuity for workers who are exposed to traffic. This includes exposure to vehicles using the highway for purposes of travel, roadway temporary traffic control (TTC) zones or from work vehicles and construction equipment within a roadway temporary traffic control (TTC) zone.
TYPE P (Public Safety)	
	Provides enhanced daytime and nighttime visual conspicuity for emergency and incident responders and law enforcement personnel in environments which include exposure to traffic. This Type provides additional options for emergency responders, incident responders, and law enforcement with competing hazards or who require access to special equipment.

PERFORMANCE CLASS 3 (Type R & Type P)	
 	Performance Class 3 can offer greater visibility to the wearer in both complex backgrounds and through a full range of body movements by mandatory placement of background, retroreflective and combined-performance materials on sleeves and pant legs (if present). Regardless of the area of materials used, a sleeveless garment or vest alone shall not be considered Performance Class 3.
SUPPLEMENTAL CLASS E

Categories of Head Protection



HARD HATS

- All hard hats in this brochure meet the requirements outlined in ANSI/ISEA Z89.1-2014
- Designed to protect from falling objects and electrical shock (class dependent)
- Typically consist of a shell and the suspension that work together as a system



BUMP CAPS

- Bump Caps are great for applications where hard hats are not required, but some protection from minor bumps and scalp lacerations are needed

- Sometimes designed to look similar to a low-profile baseball cap
- Does NOT meet ANSI standards for head protection




Types of Hard Hats

The ANSI/ISEA Z.89.1-2014 Standard divides hard hats into two categories for impact protection:

TYPE I

Intended to reduce the force of impact resulting from a blow only to the top of the head



TYPE II

Includes a foam liner between the shell and the suspension. Intended to reduce the force of lateral impact from the sides or top of the head



Hard Hat Daily Inspection

For care and maintenance guidance, you should reference the manufacturer's care and maintenance instructions. Many manufacturers recommend a daily inspection and to replace any hard hat demonstrating:¹

- Signs of breakage, cracks, discoloration or chalky appearance on the shell
- Brittleness — you can check by flexing the brim
- Signs of cracks, breaks, frayed straps or damaged stitching on the suspension



If any of these conditions exist, following the manufacturer's guidelines for replacing the helmet or suspension before use.

Care and Maintenance

For care and maintenance guidance, you should reference the manufacturer's care and maintenance instructions. Many manufacturers recommend following these steps to make sure your hat is well cared for:²

- Clean your hat regularly with mild soap and warm water. Avoid harsh detergents.
- Do not use paints, solvents or hydrocarbon-type cleaners such as M.E.K., thinner, gasoline or kerosene on your hat as they can cause unnoticeable damage.
- Do not throw it, sit on it or use it as a support. Avoid dropping your hat.
- When not in use, store your hat in a clean, dry area in temperatures that do not exceed 120 degrees Fahrenheit.
- Hard hats should not be kept on the rear window shelf of an automobile, in the bed of pickup or in direct sunlight.
- Hard hat replacement: Most manufacturers recommend replacing your hat every 2-5 years, and replacing the suspension every 12 months.

Arc Flash Services

OSHA and the National Fire Protection Association (NFPA) make it clear that employers must assess the workplace for hazards. Not just general hazards, but those that necessitate the use of PPE. There are three known electrical hazards: Arc Flash, Arc Blast and Electrical Shock. Each of these hazards requires use of PPE as well as identification through a process known as Arc Flash and Shock Risk Assessment.

- 29 CFR 1910.132(d)(1) states: "The employer shall assess the workplace to determine if hazards are present, or are likely to be present, which necessitate the use of personal protective equipment (PPE). If such hazards are present, or likely to be present."
- NFPA 70E Article 130.5 states: "An arc flash risk assessment shall determine if an arc flash hazard exists, the arc flash boundary, and the PPE to be used within the arc flash boundary."
- NFPA 70E Article 130.5 (G) states: "The incident energy analysis (arc flash risk assessment) shall be updated when changes occur in the electrical distribution system that could affect the results of the analysis. The incident energy analysis shall also be reviewed for accuracy at intervals not to exceed 5 years."
